# PRODUCT DESCRIPTION

The bi-fold door is an aluminum clad wood door. The aluminum clad wood bi-fold doors evaluated in this report are non-impact resistant doors. This product evaluation report is for new bi-fold aluminum clad wood doors based on the following tested construction:

# PRODUCT DESCRIPTION (Continued)

#### Glazing Description Key:

IG-1: Sealed insulating glass units. The sealed insulating glass units are comprised of two lites of  $\frac{5}{32}$  " thick fully tempered glass lites separated by an aluminum box spacer system.

### Glazing Method Key:

GM-1: The panels are interior glazed against a backbedding material and secured with a  $\frac{3}{8}$ " x  $\frac{5}{8}$ " wood stop moulding using 18 gauge x 1" brad nails located at 1" from the ends and spaced 6" o.c. thereafter.

**Frame Construction:** The frame members are formed from extruded aluminum. The corners are coped, butted and sealed with a foam gasket.

**Panel Construction:** The panel rails and carrier stiles are constructed of laminated finger jointed Pine with a 0.050" thick veneer on the interior and a 0.060" thick roll form aluminum cladding on the exterior. The panel flush bolt siles consists of Pine veneered timber strand with a 0.050" thick veneer on the interior and a 0.060" thick roll form aluminum cladding on the exterior.

**Impact Resistance:** These door assemblies do not satisfy the Texas Department of Insurance's criteria for protection from windborne debris. These door assemblies will need to be protected with an impact protective system when installed in areas where windborne debris protection is required.

Acceptance of Smaller Assemblies: Door assemblies with dimensions equal to or smaller than those specified above are acceptable within the limitations specified in this report.

## INSTALLATION INSTRUCTIONS

**General:** The door assembly shall be prepared and installed in accordance with the manufacturers recommended installation instructions. Detailed installation instructions and drawings are available from the manufacturer.

**Installation:** The door shall be fastened to minimum Spruce-Pine-Fir lumber.

Head: Twenty one (21)  $\frac{5}{16}$  x 4" long wood screws, five (5) at each end, starting at 4" from each end and spaced 3" o.c. thereafter, the remaining eleven (11) screws are spaced 16" o.c. along the head.

Sill:  $\frac{1}{4}$ " x 2  $\frac{1}{2}$ " long Tapcon screws located a maximum of 9" from each end and spaced 23' o.c. thereafter.

Jambs: No. 10 x 2  $\frac{1}{2}$  " long screws located at 7", 17", 42  $\frac{1}{2}$  ", 69  $\frac{1}{2}$  " and 88  $\frac{1}{2}$  " along each jamb starting from the threshold.

**Note:** The manufacturer's installation instructions shall be available on the job site during installation. All fasteners shall be corrosion resistant as specified in the International Residential Code (IRC), the International Building Code (IBC), and the Texas Revisions.
